**Resolution 1 – Increase to MBF Benefit**

**MSC**

**WHEREAS**, the MINISTERS BENEVOLENT FUND was established by the Southern Missouri District Council to provide financial assistance to family members upon the death of an enrolled minister or spouse; and

**WHEREAS**, costs of funeral arrangements and other end-of-life concerns continue to rise; and

**WHEREAS**, the District Presbytery continues to monitor the viability of the MINISTERS BENEVOLENT FUND in order that the District might provide to our ministers and spouses the best benefit at the most reasonable cost; therefore be it

**RESOLVED** that the *Bylaws of the Southern Missouri District Council of the Assemblies of God*, ARTICLE XX. MINISTERS BENEVOLENT FUND, Section 4. Benefits, Subsection A. Class-A Membership, which presently reads:

**A. Class-A Membership.** The beneficiary will receive \$1,000 if death of the member should occur during the first year of membership, \$3,000 if death of the member occurs during second year of membership, and \$5,500 if death of the member occurs during third year of membership or thereafter.

Be amended to read:

**A. Class-A Membership.** The beneficiary will receive \$1,000 if death of the member should occur during the first year of membership, \$3,000 if death of the member occurs during second year of membership, and \$6,000 if death of the member occurs during third year of membership or thereafter.

And be it further

**RESOLVED** that the *Bylaws of the Southern Missouri District Council of the Assemblies of God*, ARTICLE XX. MINISTERS BENEVOLENT FUND, Section 4. Benefits, Subsection B. Class-B Membership, which presently reads:

**B. Class-B Membership.** Class B members shall receive 6% interest added to their contributions on an annual basis. The principal and interest accrued at the time of death will be paid to the beneficiary, the amount not to exceed \$5,500.

Be amended to read:

**B. Class-B Membership.** Class B members shall receive 6% interest added to their contributions on an annual basis. The principal and interest accrued at the time of death will be paid to the beneficiary, the amount not to exceed \$6,000.

**Resolution 2 - Additional Representation on the Executive Presbytery of the General Council**

**MSC**

**WHEREAS**, the *Bylaws of the General Council of the Assemblies of God*, ARTICLE II. ELECTION OF OFFICERS AND PRESBYTERS, Section 2. Nominations and Elections, Subsection c. Nonresident executive presbyters, Sub-subsection (2) *Divisions for electing nonresident executive presbyters*, Sub-sub-subsection (c) *Additional representation*, provides for additional representation on the Executive Presbytery of the General Council as follows:

(c) *Additional representation.* The nomination process for three additional nonresident executive presbyters shall be made as follows: Each district council, at its annual meeting prior to the General Council session, may nominate three individuals from its district to the Executive Presbytery, one who is an ordained minister under 40 years of age at the time of election, one ordained female minister (no age requirement), and one ordained African-American minister (no age requirement). The members of the Executive Board of the National Black Fellowship shall also be considered nominees for the African-American ordained minister. From the nominees the General Presbytery shall select and submit to the General Council four names of ordained ministers under 40 years of age at the time of election, four names of ordained female ministers (no age requirement), and four names of ordained African-American ministers (no age requirement). The candidates shall be presented to the General Council in session and voted on by secret ballot. A two-thirds vote shall be required to elect;

and

**WHEREAS**, we, the members of the Southern Missouri District Council, have chosen to participate in the aforementioned opportunity to provide nominees to the General Presbytery for consideration as additional representatives on the Executive Presbytery of the General Council; and

**WHEREAS**, it seems appropriate that those groups specially represented by the aforementioned *three additional nonresident executive presbyters* should have first opportunity to express themselves in the choosing of nominees to be presented to the General Presbytery; therefore be it

**RESOLVED** that the *Bylaws of the Southern Missouri District Council of the Assemblies of God*, ARTICLE X. OFFICERS, Section 6. General Council Executive Presbyter Nominees, Paragraph 2, which presently reads:

In addition, the Southern Missouri District Council shall participate in presenting nominees to the General Presbytery for consideration as additional representatives on the Executive Presbytery of the General Council as described in the *Bylaws of the General Council of the Assemblies of God*, ARTICLE II, Section 2, Subsection c (2) (c). Thus, the Southern Missouri District Council shall, at its annual meeting prior to the appropriate General Council session, elect one ordained minister under 40 years of age, one ordained female minister, and one ordained African-American minister to serve as nominees for such additional representation. Election shall take place by secret ballot and a two-thirds majority vote shall be required to elect said nominees. The names of the three elected nominees shall be submitted to the General Presbytery.

Be amended to read:

In addition, the Southern Missouri District Council shall participate in presenting nominees to the General Presbytery for consideration as additional representatives on the Executive Presbytery of the General Council as described in the *Bylaws of the General Council of the Assemblies of God*, ARTICLE II, Section 2, Subsection c (2) (c). Such nominees shall consist of one ordained minister under 40 years of age, one ordained female minister, and one ordained African-American minister.

**A. Ordained Minister Under 40 Years of Age.** One ordained minister under 40 years of age shall be chosen by the District Council to serve as a nominee to the General Presbytery for consideration as an additional representative on the Executive Presbytery of the General Council. All credentialed ministers under 40 years of age within the District shall be invited to participate in a specially called caucus to be held prior to the appropriate annual meeting of the District Council for the purpose of choosing a nominee for presentation to the District Council in session. The place, time, and format of the caucus shall be announced by the District Superintendent, and the caucus shall be presided over by an Executive Officer of the District. At the discretion of the District Superintendent, the caucus may be conducted electronically, as described in Bylaws ARTICLE X (OFFICERS), Section 10 (Electronic Meetings). Opportunity shall be provided to those ministers invited to the caucus to submit absentee ballots to the District Executive Secretary between the time of the announcement of the caucus and the day of the caucus itself. Absentee ballots shall be added to the ballots cast at the caucus. The caucus shall choose, by secret ballot and by a two-thirds majority vote, the names of no more than three ordained ministers under 40 years of age to be presented to the District Council in session. The District Council in session shall be provided with the names of the caucus' nominees along with the opportunity to submit additional names for nomination from the floor. Three votes shall be required to nominate from the floor. Election shall take place by secret ballot, and a two-thirds majority vote shall be required to elect the nominee. The name of the elected nominee shall be submitted to the General Presbytery in accordance with its specified guidelines.

**B. Ordained Female Minister.** One ordained female minister shall be chosen by the District Council to serve as a nominee to the General Presbytery for consideration as an additional representative on the Executive Presbytery of the General Council. All credentialed female ministers within the District shall be invited to participate in a specially called caucus to be held prior to the appropriate annual meeting of the District Council for the purpose of choosing a nominee for presentation to the District Council in session. The place, time, and format of the caucus shall be announced by the District Superintendent, and the caucus shall be presided over by an Executive Officer of the District. At the discretion of the District Superintendent, the caucus may be conducted electronically, as described in Bylaws ARTICLE X (OFFICERS), Section 10 (Electronic Meetings). Opportunity shall be provided to those ministers invited to the caucus to submit absentee ballots to the District Executive Secretary between the time of the announcement of the caucus and the day of the caucus itself. Absentee ballots shall be added to the ballots cast at the caucus. The caucus shall choose, by secret ballot and by a two-thirds majority vote, the names of no more than three ordained female ministers to be presented to the District Council in session. The District Council in session shall be provided with the names of the caucus' nominees along with the opportunity to submit additional names for nomination from the floor. Three votes shall be required to nominate from the floor. Election shall take place by secret ballot, and a two-thirds majority vote shall be required to elect the nominee. The name of the elected nominee shall be submitted to the General Presbytery in accordance with its specified guidelines.

**C. Ordained African-American Minister.** One ordained African-American minister shall be chosen by the District Council to serve as a nominee to the General Presbytery for consideration as an additional representative on the Executive Presbytery of the General Council. All credentialed African-American ministers within the District shall be invited to participate in a specially called caucus to be held prior to the appropriate annual meeting of the District Council for the purpose of choosing a nominee for presentation to the District Council in session. The place, time, and format of the caucus shall be announced by the District Superintendent, and the caucus shall be presided over by an Executive Officer of the District. At the discretion of the District Superintendent, the caucus may be conducted electronically, as described in Bylaws ARTICLE X (OFFICERS), Section 10 (Electronic Meetings). Opportunity shall be provided to those ministers invited to the caucus to submit absentee ballots to the District Executive Secretary between the time of the announcement of the caucus and the day of the caucus itself. Absentee ballots shall be added to the ballots cast at the caucus. The caucus shall choose, by secret ballot and by a two-thirds majority vote, the names of no more than three ordained African-American ministers to be presented to the District Council in session. The District Council in session shall be provided with the names of the caucus' nominees along with the opportunity to submit additional names for nomination from the floor. Three votes shall be required to nominate from the floor. Election shall take place by secret ballot, and a two-thirds majority vote shall be required to elect the nominee. The name of the elected nominee shall be submitted to the General Presbytery in accordance with its specified

guidelines.

**Resolution 3 – Senior Status for Ministers**

**MSC**

**WHEREAS**, the 57th General Council of the Assemblies of God in session (August 7-11, 2017) adopted Resolution 6. Senior Status for Ministers, thereby amending General Council Bylaws ARTICLE VII. MINISTRY, Section 7. Senior Ministers, to read in part:

**Section 7. Senior-Retired Ministers**

In respect and honor to those ministers who have given years of service to the Fellowship, the term *senior-retired* shall be used for those who are 65 years of age or older and who have ceased to engage in any regular appointed ministry.

**a. Application for retired category.** Senior-retired status shall be granted only to those ministers who filed a request for such status with their district office. The district secretary shall forward annually to the general secretary a list of those ministers who have made these requests.

**b. Guidelines**

(1) *Reports.* Senior-retired ministers shall file an abbreviated annual report to maintain a correct mailing address.

(2) *Designation in publications.* Senior-retired ministers shall have the status indicated in the *Official List of Assemblies of God Ministers*.

(3) *Support of General Council National Leadership and Resource Center.* Senior-retired ministers shall be free to distribute as they desire the portion of their tithes previously paid to the General Council.

And

**WHEREAS**, the adoption of the aforementioned Resolution 6 eliminated the statuses *senior-active* and *senior-semiretired* from the General Council Bylaws, thus retaining only the *senior-retired* status; and

**WHEREAS**, the adoption of the aforementioned Resolution 6 also clarified the procedure for granting *senior-retired* status; and

**WHEREAS**, the Southern Missouri District Council, in voluntary cooperative fellowship with the General Council of the Assemblies of God, is resolved to bring its Bylaws into agreement and conformity with the General Council Bylaws; therefore be it

**RESOLVED** that the *Bylaws of the Southern Missouri District Council of the Assemblies of God*, ARTICLE XV. MINISTRY, Section 5. Official List, Subsection B. Senior Ministers, which presently reads:

**B. Senior Ministers.** Those ministers who shall reach the age of 65 or older shall be given status of recognition as senior ministers. A minister who is active more than half-time in ministry shall be listed as senior-active; a minister who gives one-half or less time to the ministry shall be listed as senior semi-retired; a minister without regular ministry shall be listed as senior-retired.

Be amended to read:

**B. Senior-Retired Ministers.** In respect and honor to those ministers who have given years of service to the Fellowship, the term *senior-retired* shall be used for those who are 65 years of age or older and who have ceased to engage in any regular appointed ministry. Senior-retired status shall be granted only to those ministers who filed a request for such status with the District Office. The District Executive Secretary shall forward annually to the General Secretary a list of those ministers who have made these requests.

And be it further

**RESOLVED** that the *Bylaws of the Southern Missouri District Council of the Assemblies of God*, ARTICLE XVIII. FINANCES, Section 2. Manner of Remitting, Subsection F. Support of Senior Ministers, which presently reads:

**F. Support of Senior Ministers.** Senior-active and senior semi-retired ministers shall continue to designate the required amount of support to the District headquarters. Senior retired ministers shall be exempt from this requirement. Whatever support they give shall be on a voluntary basis.

Be amended to read:

**F. Support of Senior-Retired Ministers.** Senior-retired ministers shall not be required to contribute any particular amount of their tithes to the Southern Missouri District Council. Whatever support they may choose to give shall be on a voluntary basis.

And be it further

**RESOLVED** that the *Bylaws of the Southern Missouri District Council of the Assemblies of God*, ARTICLE XX. MINISTERS BENEVOLENT FUND, Section 9. Hardship Exception, Subsection A. Senior Retired Ministers, which presently reads:

**A. Senior Retired Ministers.** Senior Retired ministers facing financial strain may make application to their Sectional Presbyter for a Hardship Exception. Each application shall be kept confidential and shall be considered on a case by case basis by the District Presbytery. Upon approval, an exception shall be granted to the minister and he or she shall be exempted from the required contributions.

Be edited to read:

**A. Senior-Retired Ministers.** Senior-retired ministers facing financial strain may make application to their Sectional Presbyter for a Hardship Exception. Each application shall be kept confidential and shall be considered on a case by case basis by the District Presbytery. Upon approval, an exception shall be granted to the minister and he or she shall be exempted from the required contributions.

**WHEREAS**, James T. Bradford, Ph.D., has served our Lord Jesus Christ and the Assemblies of God with great distinction as a minister of the gospel for 39 years, having been licensed to preach on May 1, 1979, and ordained on April 14, 1982; and

**WHEREAS**, Dr. Bradford has served The General Council of the Assemblies of God as General Secretary with exceptional Christian excellence since his appointment to that office in February, 2009; and

**WHEREAS**, Dr. Bradford has submitted his resignation as General Secretary of The General Council of the Assemblies of God in order to pursue full-time pastoral ministry; and

**WHEREAS**, Dr. Bradford has served for nearly four decades in pastoral ministry, having fulfilled assignments as Chi Alpha Campus Pastor at the University of Minnesota, pioneer Pastor of Sojourn Campus Church in Minneapolis, Minnesota, Pastor at Newport-Mesa Christian Center in Costa Mesa, California, Pastor at Broadway Church in Vancouver, British Columbia, and Pastor at Central Assembly of God in Springfield, Missouri; and

**WHEREAS**, Dr. Bradford has served on executive boards including those of Vanguard University, the Southern California District Executive Presbytery, Evangel University, the General Council Executive Presbytery, and the General Presbytery of the Assemblies of God; and

**WHEREAS**, Dr. Bradford continues now to serve the body of Christ in pastoral ministry as Pastor at Central Assembly of God in Springfield, Missouri; and

**WHEREAS**, Dr. Bradford has distinguished himself among us as an exemplary servant leader, being richly evidenced by his spirit of genuine love, sincere kindness, and Christ like humility; and

**WHEREAS**, Dr. Bradford has further distinguished himself among us as a skilled and anointed overseer, full of the Holy Spirit and wisdom, excelling in faith, marked by integrity and diligence, correctly handling the word of truth, and showing himself to be one who watches his life and doctrine closely; and

**WHEREAS**, The Apostle Paul in his New Testament letters urged the Church to give honor to whom honor is due and further declared that the elders who direct the affairs of the church well are worthy of double honor; and

**WHEREAS**, Dr. Bradford has proven himself faithful as he has walked and worked among us; and

**WHEREAS**, As members of the Southern Missouri District Council of the Assemblies of God, we have enjoyed the privilege of serving alongside Dr. Bradford as close kindred and in dear fellowship; and

**WHEREAS**, Article IX, Section 3, paragraph j, of THE CONSTITUTION OF THE GENERAL COUNCIL OF THE

ASSEMBLIES OF GOD makes provision for persons of such faithfulness and distinction as Dr. Bradford to be chosen as honorary general presbyters of The General Council of the Assemblies of God; and

**WHEREAS**, Article II, Section 2, paragraph d, (9), of THE BYLAWS OF THE GENERAL COUNCIL OF THE ASSEMBLIES OF GOD further describes the rights and privileges of such honorary general presbyters; and

**WHEREAS**, Dr. Bradford meets and exceeds the qualifications specified by the THE CONSTITUTION OF THE GENERAL COUNCIL OF THE ASSEMBLIES OF GOD for election by the General Council to the position of honorary general presbyter; therefore be it

**RESOLVED** that this 104th session of the Southern Missouri District Council of the Assemblies of God request that the General Presbytery approve James T. Bradford for election as honorary general presbyter of The General Council of the Assemblies of God by the General Council in session; and be it further

**RESOLVED** that the Southern Missouri District Council express its heartfelt appreciation to Dr. James T. Bradford for his loyal and loving service to our Assemblies of God fellowship.
